0. EXECUTIVE SUMMARY

This Policy includes the following terms with respective definition provided:

Enel Group - a group of companies under common control of the holding Enel

Environmental impact - Any change to the environment, whether adverse or beneficial, wholly or partially resulting from the Company's activities, products or services (ISO 14001:2004, 3.7).

Health and Safety and Environmental Integrated Management System; HSE IMS - Part of an organization's management system used to develop and implement its OH&S and environmental policy and manage its environmental aspects and OH&S risks.

Note 1: A management system is a set of interrelated elements used to establish policy and objectives and to achieve those objectives.

Note 2: A management system includes organizational structure, planning activities, responsibilities, practices, procedures, processes and resources.

Continual improvement - Recurring process of enhancing the EHS management system in order to achieve improvements in overall environmental and OH&S performance consistent with the Company's HSE policy.

According to the Codes of Ethics enforcing behaviour towards the principles of corporate social responsibility, everybody operating in Enel Group is committed and involved into the enhancement and improvement of environment, health and safety protection.

We aspire to reach the "Zero Accidents" goal by prevention of any accidents and occupational diseases. For us, no work can be allowed that compromises safety. For this reason, as stated in our Stop Work Policy, any unsafe behaviour or situation must be immediately reported.

The principles of the Health, Safety and Environment Policy are the following:

- compliance with health, safety and environment legislation and other requirements;
- constant evaluation of health and safety risks related to work processes and implementation of a systematic approach that aims at eliminating risk at its source or, when not possible, minimizing it, with a priority to collective protective measures over individual ones;
- implementation of all the necessary measures to avoid or mitigate environmental impacts in construction, operation and decommissioning of installations by control of raw materials, emissions, waste and liquid releases and by continuous improvement of efficient use of resources;
- constant commitment of employees in order to improve the self-awareness and adoption of safe and environmentally sustainable behaviour;
- promotion of training and information initiatives in order to spread and consolidate a health and safety culture and environmental awareness;
- provision of equipment and tools compliant with the health and safety law and respect of ergonomic principles in the work organization and in workplaces design;
- adoption of the best technologies and practices available, in conjunction with the updating and optimization of operative processes, in order to ensure continuous improvement of health and safety standards and both external and internal environmental conditions to workplaces;
